## **Conditions of Reservation**

- 1 Only registered Taylor's University or Taylor's College students may apply for accommodation with Taylor's Hostel Management.
- 2 All successful applicants are required to fulfil an initial one-year tenancy agreement.
- 3 Applicants are required to pay a Deposit of RM3,000 (USD750) and a non-refundable Application Fee of RM500 (USD125) when submitting the application form. Unless officially notified by Taylor's Hostel Management in writing, the deposit does not guarantee confirmation of desired room type at selected location.
- 4 The deposit is refundable upon the following conditions:
  - The applicant cancels the room booking with written notice a minimum of one (1) month before the PROGRAMME COMMENCEMENT DATE, OR
  - The applicant fulfils the initial one-year tenancy agreement, and subsequent renewed tenancy (if any).
- 5 Should the applicant fail to check-in after the PROGRAMME COMMENCEMENT DATE, no refund will be given for all payments made and the room reservation will be released immediately without further notice.
- 6 Applicants are required to pay six (6) months advance rental prior to check-in. Thereafter, rental must be paid every six (6) months in advance.
- 7 Rental rates are subject to change. Taylor's Hostel Management will do its best to inform all affected residents. Any other charges including, but not limited to, utilities and penalties will be imposed at the discretion of Taylor's Hostel Management.
- 8 Based on check-in date, the following shall apply:-
  - From 1st to 15th of the month full month rental
  - From 16th to 31st of the month half month rental
- 9 Rental rates are inclusive of 180 hours complimentary prepaid air conditioning usage per room. Top-ups are available.
- 10 Rooms are allocated on first-come-first-serve basis at the discretion of Taylor's Hostel Management. All reservations made are not transferable.
- All refunds (subject to fulfillment of stipulated terms and conditions) must be claimed by the applicant or the applicant's parent/guardian/next of kin within one (1) year from the checkout date. If not claimed within the stipulated time, it is deemed that the Applicant agrees to donate the amount to Taylor's for refurbishment, upkeep, improvement and/or maintenance purposes.
- 12 Taylor's Hostel Management reserves the right to proceed with any and all refurbishment, improvement, inspection and/or maintenance works in all units and rooms as and when necessary. Residents may not deny any staff/appointed contractor entry into any and all units and rooms.
- 13 Taylor's Hostel Management reserves the right to change/amend any of the conditions stated above where necessary without prior notice.
